George Martin Dixon, for many years a leading and influential citizen of the south end of the county, died at his home in Hodgenville January 9, after an illness of several weeks. He was the son of Henry and Nancy Dixon, born December 29, 1851, making him 75 years and 10 days old. In early life he united with the Cumberland Presbyterian Church at Magnolia. February 25, 1875, he married Sarah F. Lamkin. Twelve children were born unto them. His wife and 10 children survive him. All of his 6 sons and 4 daughters were with him when the end came except 1 daughter. Two brothers, 1 sister and 11 grandchildren also survive him. For many years he conducted a store at Parkers Grove. He moved to Hodgenville a few years ago on account of declining health. Burial was at South Fork Cemetery in the Dixon family lot on last Monday.
